#### Article 1

The AUSTRALIAN PEACEKEEPER & PEACEMAKER VETERANS ASSOCIATION (APPVA) will affiliate with the SOLDIERS OF PEACE INTERNATIONAL ASSOCIATION (SPIA).

#### Article 2

The affiliation will permit our action to be coordinated on an international level.

#### Article 3

The actions undertaken will be in total harmony with the SPIA goals and the role and actions of the United Nations.

#### Article 4

The SPIA will acknowledge only one Association in each country.

#### Article 5

The SPIA pledges to allow total independence on a national level to the above named Association.

#### Article 6

The APPVA agrees to encourage close relations with, and to make known the SPIA and its aims and objectives.

#### Article 7

The SPIA undertakes to refer all eligible members to their National Association, who will become members via their home Association.

#### **Article 8**

The SPIA will only consider membership from military personnel who have served the United Nations within the structure of an army.

Civilian personnel who have served the United Nations or represented the United Nations cause could become affiliated members.

The personnel not mentioned above who have rendered enormous services to the Association and the cause it defends could become honorary members.

#### **Article 9**

The ~~AIIPA~~ <sup>APVA</sup> and the SPIA mutually undertake to promote by every adequate means the Association mutual interests and if necessary to participate towards its promotion directly or indirectly.

#### **Article 10**

The provision of the present agreement is laid down for a probationary period of one year.

The agreement will automatically be renewed to the extent where neither party wishes to annul it.

#### **Article 11**

The present protocol could be followed by an agreement binding the two Associations for an unlimited period, thus this agreement will become null and void.

#### **Article 12**


The signing of the present agreement will be published in the press for advertising purposes in the respective countries.
